EDUCATION: TETON RAPTOR CENTER provides educational programs onsite and through outreach to schools and at events in an effort to deepen the understanding of and appreciation for birds of prey and their habitats. Our live raptor learning experiences and demonstrations highlight the following topics: traits of raptors, adaptations of diurnal and nocturnal raptors, fables and stories about raptors, local birds of prey, predator and prey relationships in a food chain, conservation trends relating to raptors. Between January 1st and May 31st, Teton Raptor Center's talented staff, along with the aid of eight avian ambassadors, conducted 110 programs for 9,294 participants. The newest addition to the resident raptor team is a Barn Owl. Since 2010 See Form 990, Page 2, Part III, Line 4a (continued)

CONSERVATION: TETON RAPTOR CENTER supports and leads on-the-ground conservation initiatives to protect birds of prey and their habitat. In 2016, TRC's conservation programming continued scientific studies and research on Great Gray Owls, Rough-legged Hawks, Golden Eagles and Greater Sage-grouse. New studies initiated in 2016 include research on Flammulated Owls, Northern Goshawks and Bald Eagles. The Port-O-Potty Owl Project, an initiative to help protect cavity-nesting owls from entrapment within vault toilets on our public lands continues to expand. In the first five months of 2016, Teton Raptor Center distributed 785 vent screens and expanded the project to four new states including South Carolina, See Form 990, Page 2, Part III, Line 4b (continued)

REHABILITATION: TETON RAPTOR CENTER offers rescue, emergency medical treatment, and rehabilitive care to injured, ill, and orphaned birds of prey in an effort to return these birds to the wild. TRC is one of only two facilities in the state of Wyoming offering this scope of care for raptors. Between January 1 and May 31, 2016, TRC admitted 38 raptors representing 15 species. During the same period, we reunited, fostered and otherwise deflected 11 uninjured fledglings and chicks and 3 non-raptor fledglings, by serving as an educational resource in the community. The most common cause of admission was trauma from car strikes, and electrifications. Great Horned Owls were the most common species admitted.
