EDUCATION: TETON RAPTOR CENTER provides educational programs onsite and through outreach to schools and at events in an effort to deepen the understanding of and appreciation for birds of prey and their habitats. Our live raptor learning experiences and demonstrations highlight the following topics: traits of raptors, adaptations of diurnal and nocturnal raptors, fables and stories about raptors, local birds of prey, predator and prey relationships in a food chain, conservation trends relating to raptors. In FY 16-17, Teton Raptor Center's talented staff, along with ten avian ambassadors, conducted 441 programs for 28,449 participants. Teton Raptor Center added four new resident raptors to the team in the past year, including See Form 990, Page 2, Part III, Line 4a (continued)

RESEARCH/CONSERVATION: TETON RAPTOR CENTER supports and leads on-the-ground conservation initiatives to protect birds of prey and their habitat. In FY 16-17, TRC's conservation programming continued scientific studies and field research on Great Gray Owls, Bald Eagles, Rough-legged Hawks, Golden Eagles, Northern Goshawks, and Greater Sage-Grouse. New studies initiated in 2017 include research on Flammulated Owl nest sites, lead presence in Golden Eagles, and studying occupancy of forest raptors in the Bridger-Teton National Forest using automated recording units. In FY 16/17, Teton Raptor Center's Port-O-Potty Owl Project, aimed at protecting cavity-nesting wildlife, expanded to 11 new states. Since See Form 990, Page 2, Part III, Line 4b (continued)

REHABILITATION: TETON RAPTOR CENTER offers rescue, emergency medical treatment, and rehabilitive care to injured, ill, and orphaned birds of prey in an effort to return these birds to the wild. TRC is one of only three facilities in the state of Wyoming offering this scope of care for raptors. In FY 16-17, TRC admitted 144 raptors representing 23 species from Wyoming and Idaho. During the same period, we reunited, fostered and otherwise deflected numerous uninjured fledglings and chicks, by serving as an educational resource in the community. Car strikes, gunshot wounds, window strikes, and electrifications were the leading causes for admission. Great Horned Owls were the most common species admitted.
