EDUCATION: TETON RAPTOR CENTER provides educational programs onsite and through outreach to schools and at events in an effort to deepen the understanding of and appreciation for birds of prey and their habitats. Our live raptor learning experiences and demonstrations highlight the following topics: traits of raptors, adaptations of diurnal and nocturnal raptors, fables and stories about raptors, local birds of prey, predator and prey relationships in a food chain, conservation trends relating to raptors. In 2015, Teton Raptor Center delivered 360 programs to 18,156 participants. Since 2010, TRC has provided over 2,100 educational programs with live raptors for more than 105,000 participants.

CONSERVATION: TETON RAPTOR CENTER supports and leads on-the-ground conservation initiatives to protect birds of prey and their habitat. In 2015, TRC's conservation programming expanded to include new scientific studies and research on Great Gray Owls, Rough-legged Hawks, Golden Eagles and Greater Sage-grouse. TRC also led the MAPS (Monitoring Avian Productivity and Survivorship) program in Teton County, contributing to a dataset that is over 25 years old. The Port-O-Potty Owl Project, an initiative to help protect cavity-nesting owls from entrapment within vault toilets on our public lands continues to grow. In 2015, Teton Raptor Center distributed 1,879 vent screens in 10 different states. Since 2010, TRC has distributed over 5,500 screens in 16 states from Alaska to Texas.

REHABILITATION: TETON RAPTOR CENTER offers rescue, emergency medical treatment, and rehabilitive care to injured, ill, and orphaned birds of prey in an effort to return these birds to the wild. TRC is one of only two facilities in the state of Wyoming offering this scope of care for birds of prey. In 2015, TRC admitted 130 raptors (the most ever in our history), representing 24 species. The main causes of admission were trauma from car strikes, and electrifications. Great Horned Owls were the most common species admitted. Between 2010 and 2015, the number of raptor admissions rose by 171%. All of Teton Raptor Center's programming is largely dependent on the time and talent of volunteers, especially in the See Form 990, Page 2, Part III, Line 4c (continued)
