EDUCATION: TETON RAPTOR CENTER provides educational programs onsite and through
outreach to schools and at events in an effort to deepen the understanding
and appreciation for birds of prey and their habitats. Our live raptor
learning experiences and demonstrations highlight the following topics: traits
of raptors, adaptations of diurnal and nocturnal raptors, fables and stories
about raptors, local birds of prey, predator and prey relationships in
a food chain, conservation trends relating to raptors. In FY 2017-18, Teton
Raptor Center's talented staff, along with the aid of thirteen avian
ambassadors, conducted 392 programs for 27,334 participants. Teton
Raptor Center added three new resident raptors to the team in the

RESEARCH/CONSERVATION: TETON RAPTOR CENTER supports and leads on-the-ground
conservation initiatives to protect birds of prey and their habitat. In
FY 2017-18, TRC's studies include field research and conservation
planning on 12 distinct projects across the Intermountain West and
Great Plains, with active partnerships with 14 agencies and organizations.
TRC's research team develops innovative research tools, including the
SoundScout acoustic recorder.
In FY 2017-18, Teton Raptor Center's Port-O-Potty Owl Project, aimed
at protecting cavity-nesting wildlife from entrapment in vault toilets,
reached a significant milestone, expanding to all 50 states, the U.S.

REHABILITATION: TETON RAPTOR CENTER offers rescue, emergency medical
treatment, and rehabilitative care to injured, ill, and orphaned birds
of prey in an effort to return these birds to the wild. TRC is one of
only three facilities in the state of Wyoming offering this scope of care
for birds of prey. In FY 2017-18, TRC admitted 128 raptors representing
21 species from Idaho and Wyoming. During the same period, we reunited,
fostered and otherwise deflected numerous uninjured fledglings and
chicks, by serving as an educational resource in the community. Car
strikes, gunshot wounds, window strikes, and electrifications, were the
leading causes for admission. Great Horned Owls were the most common
