What's Behind the Increase

The significant increase in net income from the prior fiscal year is primarily attributable to the receipt of a generous bequest and restricted gifts designated for the organization's Raptors Forever Fund.

Established as a long-term reserve, the Raptors Forever Fund strengthens Teton Raptor Center's financial resilience by providing resources that help safeguard the organization against unanticipated challenges, while also supporting high-impact initiatives that advance raptor conservation.

These contributions represent a strategic investment in the organization's long-term sustainability and mission impact.

EDUCATION: TETON RAPTOR CENTER'S education team provides meaningful purpose for twelve non-releasable raptors by engaging the public through dynamic outreach programs in schools, at community events, and in public venues such as lodges and parks. These educational and entertaining experiences are designed for audiences of all ages, emphasizing the critical role raptors play in healthy ecosystems, the impact of human choices on wildlife, and the far-reaching work of TRC's three pillars: research, rehabilitation, and education. In FY 2025-26, with support from our avian ambassadors and a dedicated team of volunteers, TRC staff delivered 383 programs (263 on-site and 120 off-site) reaching a total of 18,610 participants.

RESEARCH: In FY 2025-26, TRC advanced 11 distinct research and conservation projects across the Intermountain West and Great Plains, working in partnership with 21 agencies and organizations. The research team also invested in developing the next generation of ecologists by actively supporting two graduate students. Key initiatives included: developing a statewide conservation planning tool for Golden Eagles and Ferruginous Hawks in Wyoming; habitat modeling for multiple raptor species across seasons; and construction of artificial nest structures for Golden Eagles in the Great Plains and Ferruginous Hawks in western Wyoming. TRC also led major field studies in the Bighorn Basin, Thunder Basin, and Shirley Basin to examine the effects of human disturbance on raptor nesting success. The team published several peer-reviewed

REHABILITATION: Teton Raptor Center provides rescue, emergency medical treatment, and rehabilitative care to injured, ill, and orphaned birds of prey with the goal of returning them to the wild. As one of only two facilities in Wyoming offering this level of specialized care for raptors, TRC plays a critical role in regional rehabilitation. In FY 2025-26, TRC admitted 168 avian patients, including 148 raptors representing 21 species from Wyoming and Idaho. The clinic also treated and provided short-term stabilization for 23 other birds (representing 9 different species). The leading causes of admission included vehicle collisions, window strikes, and gunshot wounds. Red-Tailed Hawks were the most frequently admitted species, with 29 individuals treated. TRC's medical clinic also serves as a training ground for emerging
